# Editor's Preface

The 7NL, in fact holds no recognition or mention of the Sabbath or even Sunday worship or what an Adventist calls a NSL. What should - set the hairs on the back of our necks up - is how the 7NL have an emphatic death decree = an 'oppressive' law = to Rev. 13:15.

The undeniable fact of the new law of 1991 and developments of public law proves beyond doubt the NSL will be a distraction. But one thing is true these developments about the 7NL actually confirm the chilling issue of Rev. 13:15. Even if NSL was to occur, the fact remains nothing exists in all the papal publications for an oppressive law to the keeping of Sunday. Back in the 1890's the NSL was a real issue.

However - The US Constitution in the 1890's had no challenges or breaches.

Encyclicals issued by Papa speak of Sunday rest <u>Dies</u> <u>Domini</u> **and** <u>Laudato Si</u> where the latter of 2015 speaks of 'legislation',

but the context is in respect to the **Environment**. It must not be forgotten - NONE of the Encyclicals make any mention of capital punishment. Capital punishment is **excluded** in the Canon Law and Encyclicals. The Catholic theology always speaks of eternal damnation for failing their teachings. That has nothing to do with the reality of Rev. 13:15.

But what should *startle* any Bible student is the fact that a 'beastly' – 'oppressive law' exists and delivers capital punishment - a statutory punishment for transgressing any one of the 7NL for blasphemy and idolatry; albeit the fact is, it is an unused rule of law today in USA.

## Issues and Questions:

- 1) Why should then the 7NL place an imperative for awareness?
- 2) Why will the 7NL give much difficulty for people who include Stump, Clayton and Ebens (Arians) to resolve when the 7NL defines worship and why Trinitarians and Arians will never be targeted by the 7NL laws?

I will say kindly, as I have said for a long time, doubled down now - all the Arian advocates in their current state of mind will never reconcile the Godhead issue about the Father Son problem.

## Why?

Since they have not reasoned why John 1:1-3 says what it says, and what it does not say. It's this simple issue that <u>defeats</u> both Arians and Trinitarians. The problem is they impose their assumptions on who existed in eternal times since the Son came forth or was begotten or emanated as they insist. This emanated word is a bedrock term in the occult.

Here is the serious aspect – if we cannot determine, let alone be capable of discerning, why the Arian theory that can be traced to <u>occult</u> origins is deception and deviltry - it will be too late - even though all Arians 'claim' to completely disown the Trinity and trust in the Father and the Son.

Here is the thing, if like many, you have accepted and settled into the Arian Father Son teaching of Adventists like Stump and Ebens – it's important for all who read the Bible to see what John 1:1-3 says and how it relates to the warning in Rev. 14 (v. 7). Notwithstanding its direct association to the Shema of Deut. 6, otherwise the only other option you have is the warning of the beast of Rev. 13. Then that's too late!

### Why?

Settle the matter - there in fact exists another 'wrong way' to worship the Beast and its image, and if you think the doctrine of God is only about denying the Trinity - this is one thing. But what the enemy has arranged is to destroy the souls of those who deny the Trinity. Why not? Thereby a second path about the doctrine of God that Adventist have chosen to walk has what appears to be to them the total opposite and it's an easy path to join. But again, the warning issued by the first beast in Rev. 13 won't be a problem for any of the ONE GOD Father Son believers.

It's just that deceptive and deadly! Sr White trembled for the people. She never had or gave cause to tremble about the NSL.

#### God's Matrix vs the Luciferian matrix

God never made the doctrine of God deadly and deceptive. He left us plain straight forward evidence, and the facts of John 1:1-3 are easy and uncomplicated. This is the hallmark of the Great Godliness of the Elohim! John said The Two of Them both were God and existed en arche [in beginning Gr. John 1]. John never brought about a Father Son motif in the text. The fact is – it is just not there. That is the entire problem.

On this point – if God made it so plain and clear, then what was it that blurred the evidence He provided? God can never be faulted for making anything complicated that a child could not grasp.

It's one thing to be familiar somewhat to the heresy of the Trinity <u>or</u> any variations thereof and that must be banished for it is an abhorrent teaching – <u>that was the easy part</u> - but when it comes to <u>the deception of the Arian Father Son teaching</u> concerning the doctrine of God; which is the Arian teaching of Adventists like Stump and Ebens, - one is actually <u>confronted with what the Omega of deadly heresies is about</u> and specifically - it's what Sr White warned and she trembled. It's NOT Sunday law!

The issue of this theory - the Arian gnostic emanation or begotten in eternity routine of the Father Son Arian teaching - bolstered by the personification of Prov. 8; which is their only defence of the eternal past. This assumption overrules what John stated in John 1:1-3. In fact, oddly, it's the same belief of who is God as the JW's and other churches. Even worse, this Arian teaching holds its origins and can be traced back to the secret doctrine of the occult.

The connection of this Father Son teaching is a <u>sister</u> teaching of the Triune Trinity and it's found in the <u>Catechism</u>. Yes indeed!

# The doctrine of God vs the reality of the 7NL

While the 7NL has no mention of the Sabbath, the transition for our attention from the NSL to the 'rule of law' foreseen by Micah and Isaiah can be grasped from the Bible in light of the recent developments of public law.

Further, if you wish to be <u>unpleasantly surprised</u> this fact above can be determined from <u>another Millerite</u> error that was absorbed into Adventism. This specifically concerns the interpretation of the deadly wound and the identification of the first beast in Rev. 13.

We have beloved friends or relatives who have left Adventism and some who even have left God, they would be shocked to realise when this error is corrected as to what this <u>transition in Rev. 13</u> would mean to them.

Few are interested to set aside their view on the revelation of God from the Bible - let alone even examine why the Arian teaching is in fact deadly. The JW's sorted things out by changing the Greek in their **New World Translation** for John 1:1-3. A very small change, just one letter in the first verse changes the entire meaning – <u>here</u>

The <u>doctrine of God</u> is the warning about <u>'worship'</u> presented by the First Angel. (c.f. Rev. 14:6-7)

Today, the two main deceptions 1) Trinity and 2) Arian (Father Son begotten or emanated in eternity) are a subtle but tremendous attack on the First Angel. Both emphasise <u>One God</u>. The Shema said One [echad] God but how do you know the false from the true Shema? It is important to understand. [See WWN Au.Ed. Special Issue # 3 (2019); V — Nov. 15th 2019]

Why? One God?

The **One God** teaching of both the Trinity and the Arian will trigger acceptance of the 7NL under the regime of the first and second Beasts of Rev. 13 under the rule of law. The synagogue of Satan will appeal to the Bible and The Shema – there is One God!

But worse, like the many that believe the Stump - Ebens Arian view of the doctrine of God, I can promise you today, **YOU WILL NEVER** be exposed to any accusations of blasphemy by the proponents of 7NL. Why? The Father Son in eternity Arian teaching like its sister teaching - the Trinity both affirm there is **One God**. This fact cannot be disproven.
