# Editor's Preface

#### The Rule of Law

Bible background:

- Micah stated a 'rule of law' would issue from Jerusalem.
  [See Micah 4]
- Isaiah stated a 'rule of law' is decreed from Jerusalem.
  [see <u>Isa 2:3</u>]

In 1892, the Messenger of the Lord stated there would be an 'oppressive law'. See RH Dec 13, 1892.

 Observe, the phrasing in this message - doesn't say or mention a National Sunday law (NSL).

But here is the question – what did this update in the RH 1892 with absolutely no context of a NSL mean as to be regarded with the 'Lamb-like beast' of Rev 13 who speaks as a dragon and adopts the warning message of the first beast? 102d CONGRESS - 1st Session - H. J. RES. 104 - JOINT RESOLUTION - To designate March 26, 1991, as `Education Day, U.S.A.'. - HJ 104 EH

#### JOINT RESOLUTION

To designate March 26, 1991, as `Education Day, U.S.A.'.

Whereas Congress recognizes the historical tradition of ethical values and principles which are the basis of civilized society and upon which our great Nation was founded;

Whereas these ethical values and principles have been the bedrock of society from the dawn of civilization, when they were known as the **Seven Noahide Laws**;

Whereas without these ethical values and principles the edifice of civilization stands in serious peril of returning to chaos;

Whereas society is profoundly concerned with the recent weakening of these principles that has resulted in crises that beleaguer and threaten the fabric of civilized society;

Whereas the justified preoccupation with these crises must not let the citizens of this Nation lose sight of their responsibility to transmit these historical ethical values from our distinguished past to the generations of the future;

Whereas the Lubavitch movement has fostered and promoted these ethical values and principles throughout the world;

Whereas Rabbi Menachem Mendel Schneerson, leader of the Lubavitch movement, is universally respected and revered and his eighty-ninth birthday falls on March 26, 1991;

Whereas in tribute to this great spiritual leader, 'the rebbe,' this, his ninetieth year will be seen as one of 'education and giving,' the year in which we turn to education and charity to

return the world to the moral and ethical values contained in the **Seven Noahide Laws**; and

Whereas this will be reflected in an international scroll of honor signed by the President of the United States and other heads of state: Now, therefore, be it

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled, That March 26, 1991, the start of the ninetieth year of Rabbi Menachem Schneerson, leader of the worldwide Lubavitch movement, is designated as `Education Day, U.S.A.'. The President is requested to issue a proclamation calling upon the people of the United States to observe such day with appropriate ceremonies and activities.

Passed the House of Representatives March 5, 1991.

### **QUESTION:**

The first thing to figure out – how did the 'public law' of 1991 breach the First Amendment?

As you read what is in fact 'public law' of the US code was authorised and issued under a Joint Resolution of Congress back in 1991. A plain reading of the facts confirms the First Amendment was breached.

The resolution introduces a new concept of the <u>new rule of law</u> – the <u>Seven Noahide Laws</u>. (7NL)

Does this public law that requires each POTUS (President of the United States) to 'issue **a proclamation'** in fact saying what Rev 13:11-12 is saying?

# What are the Seven Noahides?

# Seven Laws of Noah

The seven laws listed by the <u>Tosefta</u> (dated to 220 CE) and the <u>Babylonian Talmud</u> (dated to 300 CE) are: [6]

1. The prohibition of **idolatry.** 

- 2. The prohibition of <u>murder</u>.
- 3. The prohibition of theft.
- 4. The prohibition of sexual immorality.
- 5. The prohibition of blasphemy.
- 6. The prohibition of eating flesh taken from an animal while it is still alive.
- The requirement of maintaining courts to provide legal recourse.

#### **Punishment**

The Talmud laid down the statutory punishment for transgressing any one of the Seven Laws of Noah (but not other parts of the Noahide code) as capital punishment [28] by decapitation, which is considered one of the lightest of the four modes of execution of criminals. According to some opinions, punishment is the same whether the individual transgresses with knowledge of the law or is ignorant of the law. [30]

## **Public endorsement - United States Congress**

The Seven Laws of Noah were recognized by the United States Congress in the preamble to the 1991 bill that established Education Day in honour of the birthday of Rabbi Menachem Mendel Schneerson, the leader of the Chabad movement:

'Whereas Congress recognizes the historical tradition of ethical values and principles which are the basis of civilized society and upon which our great Nation was founded; Whereas these ethical values and principles have been the bedrock of society from the dawn of civilization, when they were known as the Seven Noahide Laws. [37]

Recent law, recent reality?

The above information while taken from Wiki – is explaining to our dull eyes how the First Amendment of the Constitution was defeated - where it states 'Congress shall make no law respecting an establishment of religion'.

The fact is the 1<sup>st</sup> and 5<sup>th</sup> Noahides (see above listing) has everything to do with worship - the Doctrine of God and the Third Angels warning. Its clause for capital punishment is chilling and has everything to do with Rev. 13 and in contradistinction God's warning in Rev. 14 – the third angel.

 Therefore, how does this rule of law even relate to the Trinitarian or Arian understanding of the Doctrine of God? The answer is of course who is God!

- The 7NL insists their 'god' is NOT to be considered falsely [blasphemed] let alone ignored in the acceptance of "Who" is actually to be worshipped as said by the First Angel.
- For failing to follow the rule of law prophesied by Micah and Isaiah, that's capital punishment - statutory punishment for transgressing any one of the Seven Laws.
- Be it known This issue on the Godhead is a sustained attack on John 1:1-3 an unrelenting attack on the "eternal Identity" of "He who made" and incredibly the deception is in fact accepted and pronounced and coming from all quarters in and including the independents in and of Adventism. Many insist oh that's a monstrous claim alas, the deception can be proven.

Let's face it - any serious Bible student familiar with end time prophecy ought to now be checking out their belief from the Bible as to PRECISELY who were the Elohim in beginning [en arche] as set forth by John in John 1:1-3. Why? The sharp claws of the first beast are woven into in US code defeating the First Amendment. It gives the second Beast, all reason, according to the rule of law.

Therefore, to the being fully informed why the Trinity is gross heresy is one thing; you should become FULLY aware why Arian Father Son doctrine holds a deeper sense of deception, because either way these two teachings mean you lose. These are sister doctrines since both teach a Father and Son in eternity. This point must never be forgotten.

Why?

When understood why the Arian teaching is **more deceptive** than the Trinity, what this means is adherents of this version of the Doctrine of God DO NOT HAVE an argument against the first or the second beast of Rev 13. That fact must not be overlooked.
