- <sup>22</sup> And I, the glory that thou hast given to me, have given to them, that they may be one as we are one;
- <sup>23</sup> I in them, and Thou in me, that they may be perfected into one, and that the world may know that Thou didst send me, and didst love them as Thou didst love me.
- <sup>24</sup> Father, those whom Thou hast given to me, I will that where I am they also may be with me, that they may behold my glory that Thou didst give to me, because Thou didst love me before the foundation of the world.
- <sup>25</sup> Righteous Father, also the world did not know Thee, and I knew Thee, and these have known that Thou didst send me,
- <sup>26</sup> and I made known to them Thy name, and will make known, that the love with which Thou lovedst me in them may be, and I in them.'

#### **Conclusion 1**

<sup>13</sup> In Eden, the garden of God, thou hast been, Every precious stone thy covering, Ruby, topaz, and diamond, beryl, onyx, and jasper, Sapphire, emerald, and carbuncle, and gold, The workmanship of thy tabrets, and of thy pipes, In thee in the day of thy being produced, have been prepared.

#### **Conclusion 3**

The warning message of the <u>Paracas</u> is that this is the same individual [Lucifer] who was watching and crafting his plans and later brought about the scientific alteration of human genetics. - <sup>27</sup> And I see as the colour of copper, as the appearance of fire within it round about, from the appearance of his loins and upward, and from the appearance of his loins and downward, I have seen as the appearance of fire, and brightness [is] to it round about.
- <sup>28</sup> As the appearance of the bow that is in a cloud in a day of rain, so [is] the appearance of the brightness round about.

#### **Conclusion 8**

The true story of the potential in human DNA lays in this simple phrase "Christ in you" the hope of glory. - <sup>19</sup> yet a little, and the world doth no more behold me, and ye behold me, because I live, and ye shall live;
- $^{20}$  in that day ye shall know that I [am] in my Father, and ye in me, and I in you;
- <sup>21</sup>he who is having my commands, and is keeping them, that one it is who is loving me, and he who is loving me shall be loved by my Father, and I will love him, and will manifest myself to him.'

Take note of the fact that the latter part of the statement reveals that God will manifest Himself to the person who walks in the light of the knowledge of Jesus Christ and this would include a true understanding of the DNA signature. The wicked = dead ovum will not understand this.

#### The Final Ouestion:

So, the final question is - how does one interpret the signature of the Author?

It could not possibly be by way of chemicals and elements and language formulas and Gematrias = numerical meanings that forge a link with a so-called eternal essence that pervades all elements of nature down to the last molecule.

#### **Conclusion 12**

Here is why - Romans 1

- <sup>19</sup> Because that which is known of God is manifest among them, for God did manifest [it] to them,
- <sup>20</sup> for the invisible things of Him from the creation of the world, by the things made being understood, are plainly seen, both His eternal power and Godhead -- to their being inexcusable;
- <sup>21</sup> because, having known God they did not glorify [Him] as God, nor gave thanks, but were made vain in their reasonings, and their unintelligent heart was darkened,
- <sup>22</sup> professing to be wise, they were made fools,
- <sup>23</sup> and changed the glory of the incorruptible God into the likeness of an image of corruptible man, and of fowls, and of quadrupeds, and of reptiles.

#### A final question would be -

Would God use fallen DNA as a signature of His Creation considering that the book of Job mentions that the heavens are not pure in his sight? And could this verse of Romans 1 be applied to human DNA as well?

The answer is Yes and No - since the latter reveals that DNA in its fallen form, results in the question as to what took place in order for it to arrive at that state of imperfection and what is needed to bring the matter to its completeness and final recognition of truth.

God's signature is revealed in His handiwork and this is not to be interpreted as God dwelling inside of the fallen DNA of humans as the Pantheistic theories suggest. One might recall what was previously presented in <u>John 14:16-21</u> as the final answer.

<sup>11</sup> and from the time of the turning aside of the perpetual [sacrifice], and to the giving out of the desolating abomination, [are] days a thousand, two hundred, and ninety.
