The predominant concept is an order of least resistance and any resistance requites the establishment of law and order – here

That norm of social values is peace and order. One wonders - what is wrong with the Ten Commandments?

The "<u>Kingdom of Grace</u>" is a voluntary social order of acceptance of HWM.

Whereas the 10 kings of Rev 17 when considered is not the social order of HWM and in fact wars against HWM at his second coming.

17:13 These have one mind, and shall give their power and strength unto the beast. 17:14 These shall make war with the Lamb, and the Lamb shall overcome them: for he is Lord of lords, and King of kings: and they that are with him [are] called, and chosen, and faithful.

Notable detail of the ten kings described above is they have no crowns. Yet, God does say those ten kings = ten horns receive their crowns from the 8th king = the B of Rev 13:1.

The 10 crowned kings no longer hold allegiances to anything scarlet.

See Rev 17:16-18.

The end time false social contract involves all small and great rich and poor free and bond. Rev 13:16

All whose names are <u>not</u> written in the Lambs book of Life. = Rev 13:8.

Social orders of History

The Beast **THAT WAS**

= Roman Empire

The Beast IS NOT

- = Edict of Milan
- = 313 AD persecution ceases for Christians in the West and to treat Christians benevolently.

CONSTANTINE-

- = The **First Social ORDER** <u>social</u> <u>order</u> of the church
 - = the "is not period"

ARIAN BARBARIAN TAKEOVER-

It is at this point in time - the end of the transition age 476 AD that 10 successive Kings issue forth out of the dormant Roman political system.

LAST 3 ARIAN KINGS UPROOTED

= Daniel 7:8

I considered the horns, and, behold, there came up among them another horn, a little one, before which three of the first horns were **plucked** up by the roots: and, behold, in this horn were eyes like the eyes of a man, and a mouth speaking great things.

The Ostrogoths ceased to be a people after the defeat of Witigis, Totila and Teia and this was how the Ostrogoths ceased to be a people and were later absorbed into the populations of Western Europe. This took place during the second round

of warfare which began around 540 AD and ended in **553 AD**.

The restoration of the **SECOND SOCIAL ORDER** of the church-

Justinian's Royal Edict of 554 AD - here

Justinian is first of the "7 Kings" of the "Five have fallen" – Rev 17:10

Yes, the **SECOND SOCIAL ORDER** duration = 1260 years.

Yet, keep in mind, the **THIRD SOCIAL ORDER** is of the "8th King" who repudiates the scarlet church = Rev 17:11,16 and the third social order is that of 3T, along with the fourth Beast - that swallows up the planet, by way of regionalization, a contemporaneous 10 horn union = 10 kings, especially when the crowns are set upon the 10 horns as described in Rev 13:1. More on this third social order later.

Doctrine of God

The SECOND SOCIAL ORDER of the church involved the restoration of the Trinitarian faith as well as the Union of Western and Eastern Europe in one common Trinitarian faith.

The 3rd Social order of the church involved the establishment of Feudalism by way of Charlemagne as depicted in Daniel 11:39-

³⁹ And he shall deal with the strongest fortresses by the help of a foreign god: □whosoever acknowledgeth *him* □he will increase with glory; and he shall cause them to rule over many, and shall divide the land for a price.

This was exactly what <u>Charlemagne</u> did. He established <u>Fiefdoms</u> with Lords that ruled over the people.

The 4th social order ~

Otto the Great and the <u>Union of German</u> <u>states</u> = Tribes.

The 5th social order ~

Time frame of Charles V - Holy Roman Emperor - 1500's.

The time of <u>Charles V</u> was the time frame of the Protestant Reformation as well as the expansion of the Holy Roman Empire into the New World by way of the Jesuit Order as well as expanding the concept of Feudalism in the form of the Social Order of the Hacienda = Rich land owners that had servants under them to administer the land.

Add to this that the Jesuits also established what are referred to as the Paraguay reductions which was a form of Feudalism in relation to the use of the Indigenous populations in order to establish a sort of Utopian society where the Indigenous populations worked within the confines of the reductions which were like autonomous towns where the indigenous were protected under the banner of the church since they were forced to abandon their customs and tribal and religious beliefs and to conform to the conversion process of the church.

The 6th social order

The French Revolution and the rise of Republicanism.

It has been said that Napolean Bonaparte is said to have supported the French Revolution. Napoleon while being the

5th Scarlet King of Revelation 17:10 was not always in conformity to the church and he arrested the Pope in 1798 and the 1801 Concordat was not totally favourable to the church, since the lands they lost during the French Revolution, were not restored and later Napoleon was crowned Emperor of France and did not allow the Pope to crown him but and placed the crown on his own head. He was sending a message saying that the church would subservient to him.

There was once a saying by Napoleon which stated the following. "I am the sword of Charlemagne".

The 7th social order

The time frame of Fascist Italy and Nazi Germany.

Benito Mussolini being a gang leader as well as a thug rose to power by way of intimidating his enemies, as well as the King of Italy Victor Emmanuel who was fearful of Mussolini's rising power and he suggested that Mussolini reestablish ties with the Vatican since the Vatican had lost much money and Land during the time frame of the French Revolution and Napoleon well later as as reunification of Italy, when the church lost the Papal States. Mussolini would be the man of destiny which would help to reestablish the power of the church.

This <u>Lateran Treaty</u> was the basis for this <u>7th social order</u> which included Hitler, Mussolini and Franco from Spain.

ENCYCLICALS ~

Actually, the encyclicals of papa, endorse social equality and social order, like <u>LAUDATO SI</u> and <u>FRATELLI TUTTI</u> It could be said they have re-envisaged the Second Social order of the church for the modern age.

It is that the Grand Monarch = 7^{th} king will gain a temporary new social order and fabric of relations, but just as God has said the 7^{th} king lasts a short space and the "8th king who is of the seven" = $\frac{Rev}{17:11}$ has other ideas in mind for 1260-day time frame $\frac{after}{th}$ the Deadly Wound of the 7^{th} king.

CONCLUSION -

That High office of descent from the Zarah line which commands the respect of the world's leaders gives rise to the 7th king.

And while efforts are in throw to clean up things and install a peace accord and no doubt hosts the conditional aspects of the Ten King social order - all prior to the arrival of the Lion of Judah. This newer social order makes way for the counterfeit Messiah who is exalted = 2Thes2 = Rev 13.

The teaching and emphasis at that time is the Noosphere of the Jes. order = the one mind of the 10 kings with the Beast and fits hand in glove with Kab wizardry.

The 8th Social Order

Marks the time frame of the arrival of the <u>Great Monarch</u> and the basis of this social order will be the revelation of the 7th Scarlet Emperor in the latter portion of Revelation 17:10.

This specific individual will be able to trace his blood line down to King David through the Zara line of Kingship as well as leading Europe into World War III which will be a war against the King of the South - an upcoming Islamic superpower which will soon begin to push Catholic Europe perhaps by way of terrorism or intimidation.

The prophecy of <u>Daniel 11:40-45</u> mentions that he "the King of the North" will nigh completely destroy the King of the South and at the close of his military career, he will come to his end in Jerusalem and perish between the seas

and the glorious Holy Mountain. cf Rev 17:10

It is during this time frame that this 7th and final Scarlet King will be put down and V city will be destroyed. This will be the **last Social Order of the Church** and the prophecy regarding the demise of the Catholic Church is stated in Revelation 17:12-16 as well as Revelation 18.

Revelation 18 reveals all the evil works which were conducted during the previous social orders and the culmination will be witnessed by ship masters as well as the great men of the earth.

They will witness the smoke of her burning. Since this takes place within the vicinity of the Mediterranean Sea - the prophecy will come true at its appointed time. It is fully revealed in Revelation 18.

Two Witnesses ~ Exposing the problems-

Exposing something - does not create a social order. It creates social discord and this is what the Two Witnesses of Rev 11 are all about. Jesus has said - My Kingdom is not of this world = <u>John</u> 18:36. So how can the Two Witnesses be

a social order or conforming to a social theological order? That's an impossibility!

The Eighth SOCIAL ORDER is defined by Two Witnesses.

The reason is because both witnesses continuously expose the Kab wizardry until just shy of the +30 days of the Lamb Like beast of Rev 13. It would have to be said the Two Witnesses creates social discord and this is what the two are all about. The Two Witnesses sow discord but its unto the true social order = Order of Melchizedek. Christ - Our Great High Priest. Heb 3:1

If this detail were not to be the case, then the **third woe** wouldn't be necessary. Fact is, that the new social order is defined when the 7th Angel sounds his trumpet.

⁷but in the days of the voice of the seventh angel, when he is about to sound, then is finished the mystery of God, according to the good tidings which he declared to his ^[d]servants the prophets.

The second woe and time of the Two Witnesses has passed. Then arrives quickly is the time of the THIRD WOE = Rev 11:14-15

¹⁴The second woe is past; and, behold, the third woe cometh quickly.

¹⁵ And the seventh angel sounded; and there followed great voices in heaven, and they said,

The kingdom of the world is become the kingdom of our Lord, and of his Christ: and he shall reign [i] for ever and ever.

Remember - Social orders are contracts of agreement with individuals within nations and also is a covenant with God. It is written, the New Covenant is "built on better promises." See <u>Hebrews 8</u>.

It bears repeating.

And the ten horns which thou sawest are ten kings, which have received no kingdom as yet; but receive power as kings one hour with the beast.

17:13 These have one mind, and shall give their power and strength unto the beast.

17:14 These shall make war with the Lamb, and the Lamb shall overcome them: for he is Lord of lords, and King of kings: and they that are with him [are] called, and chosen, and faithful.

And they receive power as kings and war with the Beast up to the time of the second coming. Also, the false social contract involves all small and great; rich and poor; free and bond. All whose names are not written in the Lambs book of Life.

And all that dwell upon the earth shall worship him, whose names are not written in the book of life of the Lamb slain from the foundation of the world.

13:9 If any man have an ear, let him hear.

13:16 And he [This social order] causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right

hand, or in their foreheads: 13:17 And that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name.

COMMENT-

One can only conclude this is truly a devastating evaluation that has hit the ball out of the park and the home run is attempted by Team Dragon who coaches the Beast (**that is**) and are at war with HWM and also because this social contract of (Rev 13) is developed to its full potential by the Ten Kings with who have received no kingdom as yet = (REV 17:14) and as God said the 10 kings make war with the Lamb.

The loss of liberty and freedoms of the saints does not change their natural sovereignty of love of God and unto the truth unto peaceful tenure. See <u>2Thes</u> <u>2:10</u>

But when this social order of the B that "**now is**" - is coupled with the <u>7N</u> it is clear that what occurs is the melding of intensity and hits hard during the 1260 days of Matt 24:15 = the Abomination of Desolation and then amped off the scale at [+ 30 day] time frame – which is the +30 days after the expiration of the 1260 = 1290 days of Dan 12:11-12.

The strange thing is this new social order is gaining momentum that will be forged

upon a foundation to what they are now calling the Great Reset. A spiritual awareness of all things God.

If there truly was a "social order" given by the Two Witnesses - they would not have been killed in the streets and prior to that nor would they testify in sackcloth.

Their testimony is not of the nature of a social order because the First Angels warning is not a social order - it's the testimony of Jesus - to not worship the Beast or the image.

But again – a social order - implies obedience from a society or adherence to a set of norms which the nations involved would be submitting to and this simply is not the case - since after they are killed there is a social order of a great celebration of nations and individuals extending gifts to one another on account of the death of the Two Witnesses that tormented them.

The Two Witnesses wearing sackcloth is a symbol of the world's rejection to their testimony and the world's loss of the social order of the Kingdom of God. Presence of God in the Most Holy Place.

FINAL SOCIAL ORDER

The final social order is summarised as follows

13:8 And all that dwell upon the earth shall worship him (8th king), whose names are not written in the book of life of the Lamb slain from the foundation of the world.

13:9 If any man have an ear, let him hear.
