

Revelation 12,13,17 ADDENDUM

Three BEASTS 7 Heads Ten Horns

This short addendum explores the **Three Beasts** of Revelation 12,13,17 from the perspective of the **ten horns**, and will present you with another challenge which is the role of the **Fourth Beast** that **was**, **is not** and **yet is** – to be found in the portrait of metaphors of Revelation 17, 13 and identifying the seven heads of Revelation 13.

Why bother?

Because every detail in the Bible is for a purpose and data points of ancient history and prophecy to unfold are expressed in the Apocalypse and those concepts are forged in the transitional phases of the "10/10 scenario" of the **ten** *successive* ten kings and then **ten** *contemporaneous* that will help you to establish accurately why Revelation 13 is future and cannot be in the past.

So, close attention to detail is required to begin to see the plainest meaning because Revelation 13 is future.

Most will say this addendum is unnecessary.

But then HWM explaining the His status of **Alpha & Omega** in Mark 12 and Mark recorded that the "common people heard him gladly" they were not left lost in the weeds. **Read Mark 12.**

The 7 heads and Ten Horn count of Rev17 - the Scarlet B

17:3 So he carried me away in the spirit into the wilderness: and I saw a woman sit upon a scarlet-coloured beast, full of names of blasphemy, having seven heads and ten horns.

The 7 heads and Ten Horned Crowned count of Rev 13 – the First B

13:1 And I stood upon the sand of the sea, and saw a beast rise up out of the sea, having seven heads and ten horns, and upon his horns ten crowns, and upon his heads the name of blasphemy.

13:2 And the beast which I saw was like unto a leopard, and his feet were as [the feet] of a bear, and his mouth as the mouth of a lion: and the dragon gave him his power, and his seat, and great authority.

So, here is the problem with Laodicea.

Pasters, the elders in Laodicea will quibble about the leopard, = Greece, Bear = Meda P and the Lion = Babylon and respond –

"What's the point to study any further!"

but then Rev13 reads

the beast which I saw was like unto a **leopard**, and his feet were as [the feet] of a **bear**, and his mouth as the mouth of a **lion**: and the dragon gave him his power, and his seat, and great authority. 13:3 And I saw one of his heads as it were wounded to death

Yes, and the answer to this matter of ten horns of Revelation 17 and ten crowned horns of Rev13 is verse 13:3 above.

Note the following

This fatal wound could **not** be the Fall of Rome in 476AD, which is way more logical than 1798.

Yet, even 476AD is **not** satisfactory, since **554** only restored the **second social order of the church** in the West.

It could **NOT** be **1798** for the same reason.

The Church -MBMOHs the scarlet woman marked the "**is not**" period of the 4th B and the facts are clear.

The church **never** stopped functioning in **1798** with Napoleon signing another concordat in 1801.

The RCC Church was NEVER the Beast that "Was".

She rode over the "is not" period, nothing more nothing less.

The fourth Beast undergoes the transition age in the form of 10 Kings which relate to foreign religion in the form of Arian Christianity and Trinitarian Christianity,

whereas the shift in Rev 13 during the fatal wound timeframe is from Christianity into Luciferianism.

And the First **Beast** of Revelation 13 was likened unto those 3 other animals since,

it needs to be kept in mind that the Beast **that was** now rises from the bottomless pit = (Revelation 11) also represents those characteristics from the **past**,

yet, this is the reason as to why the **7 heads** in the form of descriptive animals **cannot** define the 7 heads of Revelation 13.

Why?

The 10/10 scenario of **Rev 13** is still **yet future**

and **not** within the timeline of either Rev **12** or **17**.

It only falls within the timeline of **Rev 17** at the moment that the "Ten Regionalization" takes place and the highlight of this fact is not in favour of the silly sisters of Laodicea and their prophetic constructs.

And why?

Since this transition of the 10 *contemporaneous* kings marks the demise of the Scarlet woman which to all intents and purposes is completely missing nor holds any <u>power</u> in Rev 13 once the fatal wound is healed,

and then, the planet enters into the Luciferian age. Laodiceans will respond with a comment about the leopard, bear, lion and as they insist, they have Revelation 13 solved because they bring to the table their idea of the 7 heads of the First B to be the Ancient nations of Daniel 7

= the 7 heads of Revelation **12**, as being the "truth" -

But of course, by now you will be realising

Rev 13 is future, that the Scarlet woman never existed prophetically prior to 313AD and noting from Revelation 17 the scarlet woman and her great city is destroyed and so there you have it – how does Revelation 13 begin to support their ideas in any way shape or form?

Why?

Since the role of the woman in Revelation 17 clears up that matter in the form of the 7 successive Kings of 17:10 which is the map leading to Rev 13.

Fact is that the **woman <u>never rode over those animal descriptions</u>** leading to Rome, and by the time **Rev 17:12-16** is reached this was past history

and the woman is past history as well, as presented in Revelation 18 which = Rev 17:12-16.

This is the reason as to why **Daniel 11:36** is confusing since it presents both the **Roman Emperor** as well as **the Beast**.

Daniel 11:36 = Apotelesmatic Principle.

But as many know since 1980, Faculty at Laodicea deem the Apotelesmatic concept as a horrendous anathema a grossly undesirable method of prophetic interpretation.

Well guess what!

HWM Himself established the Apotelesmatic principle with Dan 8:13 and Dan 12:12 and confirmed it with Matt 24:15. Other examples exist and if you pay attention, you will encounter this in the texts set out in this addendum with reference to Revelation 12,13,17

The description of the woman riding the Beast in Rev 17:10 should dispel any concerns of laughter from the silly sisters of Laodicea regarding who those **7 Heads** in **Rev 13** are.

They are the last 7 kings which the woman rode over up to the Grand Monarch, the **7**th **king**.

The GM receives the fatal wound = Rev13 and then comes the 8th King (The terrible king of fierce countenance) that Daniel saw after the 10 horns.

These are the same 10 *successive* horns which complete the map of Europe and then comes the crowning of the 10 horns by way of the 8th King = Zecharia 8:23.

And Yeh, it's true the ancient nations = animal metaphors ran amok and that was prior to the Fourth B and the fact is a residual patina of their character would exist with the First B of Rev13

And the reason you can "Amen" to this important detail is because the dragon was involved specifically in Rev12 and also, in Rev 13

Rev 12 which was **prior** to the Scarlet B of Revelation 17 and the woman or church of Revelation 17 had no prophetic existence with the "7 heads" of the Great Red Dragon and then came the **Fourth** B –

was, is not, yet is

but here is where the various transitions or phases of the animal metaphors **still hold a characteristic of the old beasts prior to the 4th B.**

And the thing is this - that accumulation of stuff is carried over to the last era of time = and revealed in the patina of character of the First B but is not about the heads of that chapter in any way shape or form

Another Amen to that.

Why?

the latter days of the First B of Rev 13 is where

God rightly portrays this Beast with the Leopard, for speed, the bear feet for strength and the lion mouth evoking much power,

and also

and that this speed and power will come in the form of expeditionary forces that are swift in deployment in any part of the world along with strength and great authority.

No different from the past.

But now the picture **Rev 12:6** brings in the "**wilderness**" scenario and 1260 '**years'** and those ancient characteristics are confirmations of the Scarlet B's and the woman's reign of what Daniel was told as being the era known as the "*transgression of Desolation*" And boom –

then it carrieth to the **Apotelesmatic** of the First B = 1260 days lit = Rev 12:14 the times time and half

and the fact is

the First B of Revelation 13 has to carry the patina characteristics or likeness of the leopard, bear, Lion and also the attributes of the Great Red dragon –

and Why?

because

the Dragon is to be worshipped in the Luciferian era.

But also - the influence of the dragon of Rev 12 continues to the very end

the dragon was wroth with the woman, and went to make war with the remnant of her seed, which keep the commandments of God, and have the testimony of Jesus Christ.

= 8th king and then the Dragon is presented into the chapter 13

For those who may not have caught the full picture of metaphors until now - what is soon to be experienced is

• the second *wilderness* phase Rev 12:14 and why Isaiah 2:6 brings that into reality because

to the woman were given two wings of a great eagle, that she might fly into the wilderness, into her place, where she is nourished for a time, and times, and half a time, from the face of the serpent.

And also, because the continuance of the 4th B that was, is not and yet is = pagan, scarlet and Luciferian

God has paralleled the **Dragons** influence all down history -

the ancient aspects of the Great Red Dragon are providing an additional and continued element of a complex tapestry of what God is saying about the accumulation of all that power and strength to be unleashed at the end of time.

This prophetic is presented in the Isaiah 2:6 grasping hands with spiritualism = what HWM said was an *Abomination of Desolation* = Dan 12 and not Dan 8:13 and also, the time of the Abomination of Desolation = Matt 24:15 there is UC and Law of One – and its outright spiritualism, against the HWM who is the true A&O.

Who are the "7 heads" of Rev 13 that have 10 horns
And three of whom were subdued?

13:1 And I stood upon the sand of the sea, and saw a beast rise up out of the sea, having **seven heads** and **ten horns**, and upon his horns **ten crowns**, and upon his heads the name of blasphemy.

Based on the 10/10 scenario of Ten contemporaneous kings

Thought questions

While the future is not possible to predict in naming the ten kings why does the First B have 7 heads and who are they?

- Are the **7 heads** of Revelation **13** in fact 7 regions = 7 heads that incorporated the ten contemporaneous kings when three are subdued?
 - Are the 7 heads proportional to the transition age from Scarlet to Luciferian. Meaning the 7 heads are from Justinian to 7th king = GM. And the emphasis you will discover is not of the 7 Heads of Revelation 13 at all, but the crowned contemporaries

So, who were the 7 heads of Revelation 13?

Justinian, Charlemagne, Otto the Great, Charles V and Napoleon, King Victor Emmanuel and the GM are *successive* kings

There is then the transition to the Ten Kings = Zech 8:23 that have 10 contemporaneous kings and Dan 7 states then three heads are **subdued** but **not uprooted**.

But when?

Good question:

it could take place under the Grand Monarch [7th king] as in 3 Kings that were brought down; yet had **nothing** to do with the *successive* scenario after the fall of the first 3 Arian Kings marking the end of the transition age.

And then It may be the downfall of 3 contemporaries (= <u>Dan 7:24</u>) of the 7th king such as France, Britain, or the HRE.

The 7 heads of Revelation 13

The 7 heads of Revelation 13 are those *successive* 7 Kings from Revelation 17:10 with the 7th falling at Daniel 11:45.

Unlikely that the 7 heads are contemporaneous since they have to be successive in order to bring about and into play the 10th successive Horn.

What is the proof there is the 10/10 is 10 successive Horns and 10 contemporaneous horns?

Proof of this is that in Rev 13 the **crowns** are on the Horns,

NOT THE HEADS

It's because of Revelation **17:10** which is the prophetic map which is divided into two sections. The first 3 Arian Kings and the last are the 7 HRE Kings = the 10th successive and 10th contemporaneous Union.

Are the 7 heads proportional to the transition age from scarlet to Luciferian?

They are only proportional from the starting date of the **Barbarian** wars which began in **535AD** and ended in **553 AD**.

Meaning the 7 heads was past history

Justinian of five fallen kings then to 7th king = Grand Monarch.

This is correct since they were the last 7 *successive* Horns which when united with the last 3 Ostrogoth Kings form the prophetic yet *successive* map of Europe leading to the final contemporaneous union.

Therefore, the emphasis of Revelation 13 is **not on the** Heads, but on the ten **crowned** contemporaries

And this is correct, since they are the 10 as depicted in **Zecharia 8:23**.

It's inevitable, that Laodicea were to laugh at the **Leopard, Bear, Lion** of Revelation 13 and say – "How do you prove this?"

then Laodicea has to explain the following two scenario

Rev 12's 7 heads 10 horns and 7 crowns on the heads

And then explain the

> 7 heads 10 horns **Rev17** in comparison to 7 heads 10 horns and 10 **crowns** on the horns in **Rev13**.

This detail is charted for the reader at the end of this discussion.

The Red Dragon's heads prior to the woman represent

Babylon, Medo-Persia, Greco Macedonia =4 Leopards and the dreadful Beast culminates in the Dragon the power behind Rome.

The 10 horns represent the Transition age from Arian to PPH since the first 3 to be uprooted from history are Witigis, Totila and Teia and

the last 7 are Justinian, Charlemagne,
Otto the Great, Charls V and Napoleon and King Victor Emmanuel and the Axis
powers and then the 7th king the GM. = 10 *successive* horns.

Yet the 7heads which are crowned in Revelation 12 are indicative not of its 10 horns which are still future, but are representative of the Pax Romana of Rome

being the 7th head through which the Dragon would persecute the "man-child" that ascended to heaven.

In **Rev 17** again- the 7 heads and 10 horns are present

But in this scenario, she the woman, sits over 7 Kings which are from 554AD to the Grand Monarch and they in turn up to the 7th and that detail from Revelation 17 completes the first portion of the 10/10 scenario.

The last portion of being **Rev 13** completes the picture of the 10/10 as indicative of when,

the 10th and final Scarlet King arrives and then it's the time frame for his elimination = Revelation 17:10 = Dan 11:45 and the rise of the Luciferian age of the 8th King which culminates in a global **contemporaneous** union. = Zech 8:23

10/10 Scenario

In a nutshell 10 successive Kings commencing at the end of the transition age and its last 3 Arian Ostrogoth Kings up to the 7th of Rev 17:10

Final portion of 10/10 = the final contemporaneous union or 10 toes of Iron mixed with clay.

It makes sense the 7 crowned heads of the great red dragon were the imperial heads

Who ruled from Babylon, MP to Greece x4 and Pagan Rome as defined in Daniel 7.

Rome emerged as the 4th B with 10/10 scenario And the transition phase to the Scarlet B with a woman rider To the next transition phase to First B with 10 contemporaries

Ten Horns in Summary

Great Red Dragon has 10 horns = Arian 3 and PPH 7 = 10 horns
The Fourth B has 10 horns = Arian 3 and PPH 7 = 10 horns and a LH
Scarlet B of chapter 17 = 3 Arian and 7 PPH = 10 horns

Why allocate the "ten horns" to the Great Red Dragon as being Arian 3 and PPH 7 when the next B, the fourth had the same ten horns?

ANSWER

Because it's an undeniable fact that the Red Dragon tried to destroy the man-child by way of Rome **during** the Pax Romana.

Also factor into the account that the concept of 10 horns specifically relates to the ROMAN EMPIRE according to Daniel 7 and from a Biblical perspective one cannot create constructs of previous Empires in relation to the "10 horns" which from a Bible based perspective of Daniel 2 and 7 culminate with Rome extending to the end of the age and **not prior** to

the ROMAN FMPIRF.

The Great Red Dragon, Fourth Beast, and Scarlet Beast and rising Beast all relate to the "10 horns." The 10/10 scenario.

Q The era of the GR Dragon had ancient religions like the **Mithraic Bull cult and in the same era had the True Religion of Moses** and the Sanctuary Service - **and there was no PPH** and of course the classic being HWM destroying 185k Assyrian soldiers of Sennacherib for king Hezekiah's protection, being the era of the Great Red Dragon and the First Temple of Solomon

ANSWER

Yes, that is true, yet there is **no Bible evidence** linking these to the **10 horns** from their "evolving perspective" as they relate to the end of the transition age.

While this appears to be contradictory, the items mentioned in the highlights are in relation to the Mystery religions outside of the framework of the 10 horns.

Fact is that the time frame of the GR Dragon relates to that of the man-child and not prior.

Q Why allocate the ten-horn narrative on the GR Dragon as being Arian 3 and PPH 7 when the next B was the fourth had the same ten horns?

ANSWER

Because it's the same "Mystery" religion

10 horns is an evolving concept over time.

Point 1

Rev 12 presents the "10 horns" as future

as seen by Daniel in chapter 2 and 7, = As a prophecy which was not yet present during the Pax Romana. Same as Daniel 7 which first targets the 4th Beast. Yet not fulfilled on account of the **7th crowned** <u>head</u> which was Roman Peace throughout the ancient world.

Point 2

Rev 17 as evolving successively within the framework of Rev 17:10 and the second social order of the church.

Point 3

Rev 13 within the timeline of its completion as in the 10 successive and 10 contemporaneous.

These 3 points reveal the "WAS, IS NOT and YET IS" is to ascend from the bottomless pit"

Fact is that the time frame relates to that of the man-child and not prior.

And if you are still paying attention to this point of the addendum of Revelation 12,13,17 Dan 7 discussion you will be privileged to find another prophetic gem

The fact God established the 10/10 scenario from the time of the Great Red Dragon of Rev 12 is true – it had **ten horns**.

When the scales are removed you will realise the birth of the man child is in context of 4th B which is framed in the prophetic text of the Great Red Dragon of Revelation 12

And then bingo

The 10/10 bigger picture Sits in Rev 12.

All along.

How?


And if you see this detail then God has set out a very plain factual Apotelesmatic revelation of prophecy when the scenarios of the The two wildernesses are introduced in Revelation 12:6,14.

That detail of Revelation 12:6,14 alone tells anyone who has ears to hear and eyes to see the Apotelesmatic principle is truly valid. This is another challenge to Laodicea.

All the way thru to remnant of the woman seed. The ultimate war against the secreted ones of Psa 83.

No wonder the A&O of deadly heresies is a serious level of deadly spiritualism. And the clasping hands with spiritualism.

Ten Kings evolution over time



The fact the GREAT RED DRAGON (GRD) begins the ancient animal system in time which is on the left and then the prophecy is significantly relevant to the ten kings but at the time of the birth of the **Man Child**

which is the **critical point #1** of the GRD the Beast is the Fourth but no prophetic activity of the ten horns

Without this evidence the birth of the **MAN CHILD** which is at the time then FOURTH terrible Beast (WAS) the detail of the ten horns still has an evolving relationship with the animal metaphors.

the 10/10 scenario commences at the time of the TEN Horns of Dan 7:8 with the 3Arian kings and then followed by the successive 7 PPH kings and the 10/10 scenario holds its own in the evolution of the ten horns

The Critical 10/10 Point # 2 is the FOURTH BEAST

in BLACK and grey and its identified as **WAS, IS NOT, YET IS.** at centre of the chart.

The First B is integrated in the lime green time frame

Summary

The integration is the colour scheme denotes the reign of the 4 beasts Showing the pale yellow of the GRD and you will notice Rev 12 introduces TWO "WILDERNESS" scenarios = 12:6,14

and of course, the GRD is prophetically involved all thru time to the end when the Dragon is specified as at war with the remnant of the woman's seed = Rev 12:17 = future.

What this means is the **TEN HORNS** of the GRD is about the Animal metaphors and they are as you know replicated in the First B of Revelation 13:1-2.

But by this time of the 1290 days of Revelation 13 those characteristics prove the involvement of the ten kings of the GRD that became 3Arian and then 7 Scarlet Kings for the animal speed and fierceness then becomes the 10 contemporary king scenario = Revelation 13 and Daniel 7:23-24 as distinct with Dan 7:8 and the Fourth B.

Why bother Understanding the 10/10 scenario?

The importance of the 10/10 scenario

God has provided the prophetic details of the Ten Kings from the Great Red Dragon to the Fourth Beast; thence to the Scarlet Beast; and much prophetic activity with the First Beast of Revelation 13 in the destruction of the scarlet woman. = Rev17:12-16

The Great Red Dragon of Rev 12 has 10 horns = 10 Successive Kingdoms future from the time of Jesus Christ death on the cross and his ascension to heaven

The Impure woman of Revelation 17 also has 10 successive Kingdoms the first 3 of the 10 were the Arian Barbarian tribesmen, Witigis, Totila and Teia.

The Bible states that they were uprooted by the Little Horn a religious Kingdom of which she rode over 7 of them, see Revelation 17:10,

The woman sits over 7 Kings. Justinian was that first King that uprooted the first 3 Arian Kings.

The First Beast of Revelation 13 = the 10th and final government of the woman riding over it (her 7th Scarlet King) and then it receives a fatal wound that is later healed with another Emperor who is different from the previous 10 successive Kingdom leaders since he is a Luciferian.

His government will last a literal

3 1/2 years

Then one month later in literal time which = 30 days we arrive at the

1290 literal fulfilled days = Matt 24:15 = Dan 12:11

And the final abomination desolation takes place after the final 42 months = 1260 days in literal time

or 3 1/2 literal years of allotted time granted to the Beast which takes place after the death and ascension of the two witnesses of Revelation 11.

The Miracle Working False Prophet then takes the global spotlight as the emergent second Beast coming up from the earth

exercises all the power of the First Beast which culminates in a global law of the worship of the so-called "One super consciousness"

based on Deuteronomy 6:4,8.

You thought it was a Sunday law? Think again!

It cannot be!

The specific reasons are the following.

The fulfillment of Zecharia 8:23 = the fulfillment of Rev 17:12-16 which is the repudiation of the Scarlet woman and the helm of the ship is taken over by way of the 8th King, who is the 'diverse' King that Daniel saw in his vision after viewing the 10 horns.

Then zero in on the religious affiliation of the guy in Zecharia 8:23 and compare it to his name in Revelation 17:12-16

Question

This level of detail exists in the summary of history, past and future – but then Is this level of detail suitable for the present?

Serves as a preparatory awareness for the Loud Cry following the Ten Kings who have power "one hour" with the Beast that sees the utter destruction of the illicit woman and her great city = Rev 17:12-16 and then,

does this 10/10 King scenario implore anyone who will listen to then recognise there is WW3 with the 7th king who is the last of the 10 successive kings = Dan 11:45 who lasts a SHORT SPACE?
