# Theology of the

### LOST TRIBES?

This link above represents the very common Evangelical and even Laodicean idea, about the **lost tribes of Israel,** because they are those who apparently comport fully to the literal 12x tribal ethnicity of Revelation 7 and therefore, are the 144.

This discussion will be of interest to those who squander the essential doctrine of Christ concerning John 4:22 and the 144.

Then I heard how many people received God's seal. The number of people was 144,000. They came from all the tribes of Israel's people:

<sup>5</sup> 12,000 from Judah's tribe,
12,000 from Reuben's tribe,
12,000 from Gad's tribe,
<sup>6</sup> 12,000 from Asher's tribe,
12,000 from Naphtali's tribe,
12,000 from Manasseh's tribe,
<sup>7</sup> 12,000 from Simeon's tribe,
12,000 from Levi's tribe,
12,000 from Issachar's tribe,
<sup>8</sup> 12,000 from Zebulun's tribe,
12,000 from Joseph's tribe,
12,000 from Benjamin's tribe.

The idea in the vid is, as they say, and most of you well know, that these 12 tribes by the recognition of the naming conventions applied from the Patriarchs is Gods "A LIST" and therefore because they are naming the tribes therefore they = the long-lost tribes, and for that purpose.

In addition, as to what authenticates the A LIST is the example of the genetical / cultural bloodline = the <u>Lost Tribe of Manasseh</u> and yeh, were visited by missionaries. Well, they didn't accept the foreign religion = Christian missionaries.

Meaning they would return to Japhet unbelieving. That is the pattern of the literal bloodline story .

If, any of these will 'fall into line' in respect to the Bible's prophetic time clock, = (Matt 20), Revelation 18 declares a decision is required now and certainly necessary at the Loud Cry =  $\frac{\text{Rev } 18:1-5}{\text{Rev } 18:1-5}$ ,

The Revelation 18 cry that is conveyed with **great power.** 

But then, is there a the possibly all the 'lost tribes' taking up the call of Heaven = to come out of her my people?

There are some who claim this sealing of Rev7 will be available in the timeframe of the Two Witnesses.

= The 1260 days of Rev 11.

The latter suggestion, is a moot idea.

Talking about moot ideas, those who are fond of the literal x12 tribal conclusion of Revelation 7 = literal bloodlines, right,

well, there is something to be aware – yeh a problem, where genetics plays a large part in the attempts to establish biological tribal affiliations with Y-chromosomal haplogroups, subclades, and haplotypes

here and here

It is easily seen the preponderances of literal bloodline requires OPTIMAL PURITY, and as can be seen

does NOT exist in the genome data.

This means most of the theology of Revelation 7 will remain subjective, highly sentimental for the Messianic fervour,

but the literal tribal bloodline evidence is FADING,

because from the evidence a convincing conclusion is not possible due to tribal integration with other peoples in various populaces, over many centuries, due the ebb and flow of time.

What appears to be the logical evidence available today is the now esteemed value of 'lost' Tribal but more along the lines of a long-lived cultural purity,

and this is acknowledged by the higher Rabbinic Courts because a proven cultural existence demonstrated by a long tradition of Hebraic theological purity = Sabbath, the Ten Commandments of Moses, the Talmud and dietary norms,

and so, it confirms a necessary consistency. This is case in point with Bnei Menashe in the vid and those guys can prove their ancestral associations over long stretches of time, and yes, that counts as good.

But how does HWM see that viewpoint, Especially after what He stated

in Matt 23:38?

Ok, So what does the haplogroups and genomic statistical data indicate?

It's a weak datum set to accommodate the literal bloodline application of twelve literal tribes, that = Rev7 and therefore makes that likelihood incomplete. If not impossible to demonstrate.

It seems also pertinent – that the Japhet group know a lot about the Book of Christian Revelation and the 12 tribes of Rev7 as well.

So, who of you can explain why all of a sudden the literal lost tribe bloodlines actually reflect Revelation 7:4-8?
And therefore true?

When the Japhet guys do NOT recognise the Bible Let alone Jesus Christ as the Messiah.

So, now comes to you - the doozy of a problem.

How do **you** establish an accurate and thorough 12 tribe account and build out the necessary theology concerning Revelation 7, Yeh, with the LITERAL bloodlines in the New Vineyard?

And then, take the next step – as to what must occur when it comes to the **seal of Gd** in the closing work for the church in **the 'sealing time'** 

and

which is fully fundamental and illustrates the true essence to the theological domain of Revelation 7 and the DoA cleansing and sealing,

which is in fact, it has to be repeated once again, and must be repeated for those with poor eyesight it is John 4:22 establishes the dictum of Dan 8:14 and the Heavenly Sanctuary and the DoA and also the FA.

So, how do **you** establish an accurate and thorough 12 tribe account

and build out the necessary theology concerning Revelation 7,

#### **ANSWER**

Well, here it is – One must fully trust HWM.

He declared a literal emphatic **Divine Decree** against exactly who, in **Matt 23:38?** 

How large was the house? All 12 tribes?

How then is that that Divine Decree by HWM frame the basis of the original heirs and must include any and all future
Divine Considerations of the New Vineyard and in the last generation,
of those who will and who won't stand on Mt Sion
as per Rev 14:1. = Revelation 7

Which for clarity sake, you are reminded

HWM said it is one of the seven churches have a strange experience Because the SoS worship the feet of the Phillies, = Revelation 3.

Does that portion of detail about the Phillies not confirm **Matt 23:38.** 

<sup>38</sup> Behold, your house is left unto you desolate.

Right?

But again,

why would Egw talk about 'closing work for the church in the sealing time' of 144

when there are theological 'claims' for the literal bloodlines of the lost twelve tribes?

But then, the other problem for Laodiceans is **no commentary by Egw** 

exists for Revelation 7:4-8

The only way to resolve the enigma of the **12 named tribes** Comes down to **John 4:22** 

and the prevailing Divine Principle of the Sanctuary Doctrine – and ONLY THAT establishes the antitypical fulfilment of Lev 16 and the DoA and yes the SoG

Ok Then, that being the case -

because Revelation 7 – it's all based on Daniel 8:14.

Does not **Matt 23:38** mean what it says, that the <u>literal</u> bloodline tribes of the "House" are **all 'declared desolate'?** 

Meaning?

Meaning the tribes of the **old Covenant 'house'** cannot constitute those literal tribes of Rev7.

Well, it's easy to confirm the answer.

Paul was given the light of John 4:22 and it is illustrated in Book of Hebrews and includes the **cleansing** of the Sanctuary = Heb 9

because Paul well knew the details of Dan 8:13-14 applied to John 4:22.

But get this,

Laodicea was born of prophecy

And the dictum of John 4:22 = Dan 8:14 prevails in every aspect of Rev7 which means Bnei Menashe in the flesh are not one of the **spiritual** tribes of Manasseh. Same be the case for all literal blood linages and claims.

Also, the chaste woman in respect to the prophetic interlocutory of Revelation 12 exists to confirm other things, than a literal tribal affiliations of Revelation 7 and as was established Rev12.

This chapter as previously discussed <a href="here">here</a> – shows how GOD Delineates the facts of the **Transgression of Desolation** = Dan 8:13 and the events of **Abomination of Desolation** = Matt 24:15 midst the Beasts from Dan 7, and includes the beasts Revelation 13,17.

Now back to the 2W of Rev11 and the possibility of literal tribes "falling into line."

Fact is, **it's too late** by the timeframe of the 1290 days of Matt 24:15

-for anything,

such as the seal of Gd = Ezek 9 which was in the prior sealing time of the 144. Why?

You are deep in the time of the Second Woe.

Why?

Events leading up to Revelation 9:12 are long gone.

One woe is past; [and], behold, there come two woes more hereafter.

Also, the time of the second woe includes the 2Thes2 guy noted in Isaiah 2 <u>here</u>

#### 2Thes2 Guy and LOST TRIBES

So - Who is to say the 2Thes2 guy will NOT establish a literal lost tribe bloodline accreditation or the cultural Hebraic orthodoxy policy as a keynote objective.

Well, it's relatable to Zech 8:23.

Why?

To build-out the 3T Enterprise of real ancestral stock, back to Jacob as those who held to the Law of Moses,

which for the 2Thes2 guy means hosting and elevating literal bloodline stock, because all pertinent authentication was the long-held heritage and that brings much authority and legitimacy for 3T and what the ten men say

that ten men shall take hold out of all languages of the nations, even shall take hold of the skirt of him that is a Jew, saying, We will go with you: for we have heard [that] God [is] with you.

"We know God is with you."

Right?

But would the 8<sup>th</sup> king ever adopt what PAUL explained about the ROOTSTOCK and the branches in Romans 11?

Hardly,

Paul as LOATHED, reviled, despised by the Japhet guys.

#### OK, so would you prefer to consider another anomaly?

What would The 2W say to the

2Thes2 guy about his global recognition by the TEN KINGS and with that sort of prestige that goes with the 3T?

Keep in mind Daniel said the 8th king has much power.

Huh?

What would the 2W say at that juncture?

Anyone who can be bothered, can read the account in Revelation 11.

Guess what happens?

The 2W antipathy was extremely strong that after 3 and 1/2 days everyone gave presents to each other but to then be beholden in dreaded fear.

#### **CONCLUSION**

Would not the 2W refer to HWM and the First Angel's warning = worship HWM, and of course fully attest why He is the A&O?

Even though a small enclave like **Bne Menashe** are genuine,

would they not be fully upbeat about First Angel's warning of Rev14?

If that was the case, why would they wish to head over to the 3T?

#### **Back to Revelation 12**

The flight into the wilderness Rev 12:6 was the era of the Transgression of Desolation = 1260 years,

Commencing with the First of the Five fallen kings of Revelation 17 in 554AD under Justinian.

God said in Revelation 17 - Five have fallen.

Right?

Did not Gd take the scales off Pauls eyes to go to tribes – being of the tribe of Benjamin and take the Gospel to the GENTILES?

How are gentiles viewed by the Japhet guys at the time of the 7N?

Of course, you know the answer.

A Gospel to meet many obstacles such as the era of the '5 fallen kings' on the increments of the prophetic timeclock? Yes, the Gospel that encountered the Transgression of Desolation of the Beast that was not.

And so, during that long era the Transgression of Des there would exist the lost Hebrew cultural enclaves.

Like fully assimilated religiously culturally in other places around the earth even areas far removed from the persecution by the  $4^{th}$  B or the scarlet B, nor stomped-over in the long era of the transgression of desolation = Dan 8:13, only to be later tallied up and foiled in the Colonial era.

But again, regardless of the endless possibilities you can never omit

#### HWM's

#### decree of Matt 23:38.

The scarlet woman and the B, were busy, with business.
And led to the eras of the crypto.
The conversos, the Marranos.

What occurred demographically?

The Loss or even eradication of the indentured literal tribes with the pressures of the Inquisition and the HRE.

Just say, the enclaves were genuine and have a role in the 'sealing time of the 144' then - - - should they not acknowledge the true Messiah (HWM) And Christ had also faced the San, head, run, guy's over the 1g, 7N law in Matt 26.

Christ died according to Isaiah 53? and therefore.

concerning the enclaves, you would think they be wonton to disregard the doctrines of the 2Thes2 guy? Come hell or high water, **prior** to the events of the 1260 lit days of the First B of Revelation 13?

And you have **Rev13:8-9** to review and really consider its purpose with regards to the A&O of HWM and why this text is situated between the TWO BEASTS at the end of the 1260 and the +30 of the1290 days of Revelation 13.

The calling becomes so focused

#### "If any man hear" – 13:9

It's a Divine Calling, to ANYONE – yes that one last awareness about the First Angels warning and the importance of the Pre-eminence of ER = Col 1:16-20

Verily **ERxF** is that Divine Authority to fortify the 144.

Would the lost tribes desire be, to establish and respond to HWMs last call in the sealing time?

### Nothing is impossible, in a very short timeframe but is it plausible?

Well, for one obvious thing the 144 are a very small number.

The common interpretation of Rev 7 is a Literal blood lineage.

But as you encountered earlier - The Haplo-genome DNA configurations and indicators are one thing, but a lot of uncertain research exists.

But, here's the thing for any tribal subclade familiar with the Sanctuary Service of Exodus 25:8 and Leviticus 16 – is what God establishes on the Day of Atonement = John 4:22

= Dan 8:14

And especially for the 144.

#### What Gd establishes in the FA

#### is twofold

- 1) The cleansing = Isaiah 6 and then
- 2) the sealing = Revelation 7 = shut door and fully closed out by Trumpet #5 since one woe is past.

#### Read Rev 9:1-12.

The sealing includes the **Key of Dovid** at that time. But of the seven churches, this is given to the <u>Phillies</u>.

Read Revelation 3:7-13.

And following the seal of God Then commences the 2W testimony = 1260 lit days.

**Read** Rev 11:2-3,14

After all, because Laodicea were **born of prophecy** at the end of the **Transgression of Desolation** 

= after 1844,

right?

Then, here is the reality – the vast theology of John 4:22 is fully integrated with what seems to be the theology of Rev 7 and then, that being the case it always gets back to Laodicea, and the seven churches,

and specifically what Egw set out in

3T266-7 and 5T207.

Why?

Laodicea was born, and raised from prophecy.
Raised to ready
a people for the time HWM called the
Abomination of Desolation as spoken by Daniel the Prophet
= Matt 24:15.

To speak accurately to the First angels warning (which is **not the Sabbath**) and also, every Laodicean must realise **the seal of Gd** is **NOT the Sabbath**,

And therefore, the Closing work (today) is to respond now to the call to get out of Laodicea

and **save your life,** from the reward Alpha & Omega of Deadly Heresies

Literally, saved from the horrors of that reward.

Why?

Because those who are 'wise virgins' recognise on the DoA there is a cleansing prior to the SoG

which will mean their lips of clay are **cleansed** by the coals from off the altar **Isaiah 6** and no longer speak rubbish.

Cleansed from the heinous **God the Eternal Son** FB#4 = Omega of DHs

Cleansed lips from the TTD of the purple woman and keep in mind

GD holds full hostility this woman and her daughters because she holds the denial to the Two Divines of John 1:1 which means absolutely no Revelation 7 sealing under those circumstances

and further, God said there must be a cleansing an ATONEMENT for what is a great transgression against HWM and therefore on the DoA that awareness about the Alpha & Omega of Deadly Heresies one acknowledge and fully repent and only then ones lips will BE CLEANSED.

#### **BAR of SOAP**

For those old enough **mother** washed your mouth out, with soap.

For what? **LYING** – right?

In this case of the 'cleansing' of **Isaiah 6** on the DoA it's not as 'drastic' as mother,

but the eternal repercussions for not engrossing the "whole mind and entire attention in the sealing time," let's say for now, the outcome is far **worse** than mother. It's a shocker.

#### **FULLERS SOAP**

The other illustration of cleansing is being chastised = **refiners fire** like a bar of fullers soap

#### = Malachi 3:2

<sup>2</sup> But who can abide the day of his coming? and **who shall stand** when he appeareth? for he is like a refiner's fire, and like fullers' soap:

**Those who shall stand** - Mal 3:2 = Revelation 6:17

are the 144.

Then, be it better that one's MOUTH ceases prating the relentless ignorance which is the endless lying about HWM and His ER and why He is A&O.

Right?

Why?

- for starters it is very obvious when speaking to the padres, elders and laity in Laodicea that the **cleansing** from the **Alpha & Omega of Deadly Heresies** = **FB 2,4** 

**is extremely difficult** leaving them unable to make a decision from the Bible,

Let alone to even be bothered to make the necessary efforts to **resolve** the Alpha & Omega of Deadly Heresies and

What happens?

They all continue to **speak guile** unable to provide an accurate awareness of the GDHD and the implications to the First Angel.

For those listening, convicted of accuracy about the First Angel and the horrors of the reward for the A&O of DH -

how difficult will it be to make a decision at the time of the Loud Cry Rev 18 just after the destruction of the V city.

Why?

Gd said the V city is destroyed utterly by the Ten Kings - in one hour

What then do you do with a destroyed RCC church and all of its doctrines?

Abandon everything about it?

Right?

Have to include FB2,4 = the central doctrine of the RCC that has been destroyed = Revelation 17:16.

Right?

What you are left with THEN – the time of the Loud Cry Rev 18

is the tragic legacy of Laodicea the foolish reject the First Angel, don't believe the Loud Cry of Rev 18 because the message is **not** about the Sabbath.

Right?

Today – when one gains the necessary insights of the deadliness of the Alpha & Omega of Deadly Heresies - **you just Depart.** 

What's at stake?

#### The SEAL of Gd

Or remain with comforts of being lukewarm assuming you have the SoG which is apparently the **Sabbath**. Well, that notion is **totally debunked** 

with Revelation 3:12 and Revelation 14:1.

Right?

But then, today when this issue about the SoG is addressed, you have to deal with the appalling "look-of-you-are-lost" from the elders and the padres of Laodicea.

Whereas, <u>their</u> major problem is with God, Over the warning about the Omega of DHs that EGW provided over the Alpha & Omega of Deadly Heresies = **FBs 2,4** which is all the same as the doctrine of MBMOHs.

It's the purple woman's central doctrine.

But many turn away, and to allay the anxiety and tension that's building up to make a decision?

So, what would Paul say today, you are meant to be?

A pillar and ground of truth = 1 Tim 3:13.

### The Omega of DHs is not truth.

God could NEVER reconcile the Alpha & Omega of Deadly Heresies as being a pillar and ground of truth let alone to be sealed by that according to Revelation 7.

No way. Why?

God said when describing the Phillies

# "Him that overcometh will I make a pillar in the temple of my God,"

That pillar entails the truth about the seal of Gd in the sealing time = Phillies.

Are you still In doubt?

**READ** Revelation 3:12

<sup>12</sup> Him that overcometh will I make a pillar in the temple of my God, and he shall go no more out: and I will write upon him the name of my God, and the name of the city of my God, which is new Jerusalem, which cometh down out of heaven from my God: and I will write upon him my new name.

So, then, about the rationale of 'cleansed' -

it would be superfluous to say the lost tribes would not know about Yom Kippur the DoA, the ministration of the High Priest on the DoA= Lev 16, and the cleansing, of Ezek 9 and the Final Atonement.

#### In respect to Revelation 7 and the antitypical SoG

God said, **no guile** is the Divine Rule = cleansed from unbelief about the First Angels warning about HWM, That includes non-denial of His ER, And the non-denial that He was also God, = John1,

but then the **tragedy** is insisting HWM was / is **God the Eternal Son FB #4** and denying HWM as the ALPHA & OMEGA = LSFBTFOTW = Revelation 22:13,16.

John 1:1 proves His eternal status. It is also the basis of the Divine Authority of what SEALS THE 144 in the sealing time.

For **cleansing** – is required **prior** to the seal of Gd, and cleansing means to depart from the hivemind of Laodicea with their FBs 2,4.

At this time, one truly needs the coal from off the altar in Heaven, not from the pulpit and mentoring of Laodicea about God,

and yeh, that sears the tongue, the lips to be continuing

in **GUILE** =

#### = 1 Tim 4:2

Speaking lies in hypocrisy; having their conscience (FOREHEAD) **seared** with a hot iron;

but to be cleansed to speak truth about the First Angel and HWM = John 1:1 = = A&O = LSFBTOW = Revelation 13:8 etc

#### For what?

Simple.

To be cleansed from the unbelievably Insidious Alpha & Omega of Deadly Heresies

### Triune T doctrine = FB 2 = the God the Eternal Son FB #4

But only

to then, one can begin to see the **eternal glory** of HWM who was ALSO GOD, from eternity

- = His Eternal Identity = **EVERLASTING FATHER # 2** = Isa 9:6-7
- = Eternal Righteousness
- = HWM = First ANGELS warning.

Getting back to lost tribes "falling into line" at the time, of the 2W.

It's **too late** by the timeframe of the 1260 lit days of the First B of Revelation 13.

It's the same timeframe of Revelation 11, And forget then about anything like the seal of Gd of Revelation 7.

Of course, and even if there exist literal tribes of Israel, it **doesn't** mean anything.

Why?

since the **New Vineyard** of <u>Matt 20</u> dictates that it's the **5:00 PM** workers, that are sealed.

**READ** Matthew 20:6-9

The **5 PM** workers are the Sealed teachers of Righteousness and the rest are the students or the holy.

That statement about the Christian missionaries that preached to the lost tribe of Bnei Manasseh in India, is a taste of things to come.

As prophetic time moves to the events of **Isaiah 2** There will be the renewed pride of restoration and emphasis on the Law.

These lost tribe guys will not easily come to Christ unless it's a miracle of HWM,

like when V city takes its fall. = Rev 17:16.

Then the last opportunity to hear and respond is to the Loud C.

As will be the case for Laodicea and all others.

#### The Tertiary Level of Revelation 7

Then there is a tertiary level concerning the vast theology details of Revelation 7, which is the timeframe of the 2thes2 guy and the 1290 days of, of the Abomination of Desolation = Matt 24:15 when the rubber meets the theological pavement and what is this tertiary level?

#### The ROD

Contrary to what is stated by Satan, the fact is the 144 Will refuse to come under the Rod.
The Rod is the tertiary level.

**READ** Ezekiel 20:37

<sup>37</sup> And I will cause you to pass under the rod, and I will bring you into the bond of the covenant:

#### **READ** Revelation 12:11

<sup>11</sup> And they overcame him by the blood of the Lamb, and by the word of their testimony; and they loved not their lives unto the death.

The Rod of the 8<sup>th</sup> king undoubtedly exists, during the 1260, and the +30 days of the 1290 of Rev 13 and will be a major delusion and to the world, it will seem like the tribes are restored. The rod effectuated upon what the 8<sup>th</sup> king calls, imposters.

The great multitude and the 144?

#### The Rod effect?

Yeh, it is noted clearly in Dan 8:23-25.

<sup>23</sup> And in the latter time of their kingdom, when the transgressors are come to the full, a king of fierce countenance, and understanding dark sentences, shall stand up.

<sup>24</sup>And his power shall be mighty, but not by his own power: and he shall <u>destroy</u> wonderfully, and shall prosper, and practise, and shall <u>destroy</u> the mighty and the holy people.

<sup>25</sup> And through his policy also he shall cause craft to prosper in his hand; and he shall magnify himself in his heart, **and by peace** shall **destroy** many: he shall also stand up against the Prince of princes; but he shall be broken without hand.

But when all is said and done, the main issue is still the First angels warning. Years ago, Benny Hinn was trying to fulfill the literalness of Rev7 prophecy by flying in people from places either Russia or Ethiopia.

And if the Bnei Manashe are genuine then it's the recognition of the First Angel and as we can see that they see their 'birthright' is currently following the 1g of the world which is **against** the First Angel warning and leading themselves to the adoption of the 7N @ the 3T Enterprise.

In fact, No one these days understands the reason as to why the Second B is linked with Japhet. That is, the reason = 3T and 7 N.

The global Magan network is all linked under the table, and the rest is theatre, for the world.

But as mentioned,

Paul was given insights about Jn 4:22 and this is cited with his concise treatise concerning the Heavenly and its cleansing in Heb 8,9,10, = Dan 8:13-14,

because Laodicea was born of prophecy at the time of 3pm

and Laodicea are certainly not along the lines of the Bnei Menashe bloodline = 12x archetypes, who are said to be indicators of the Lost Tribes and therefore not the <u>literal 144</u> because as is commonly believed are a literal example of the lost tribes, and that's a problem.

Fact is – It's the old workers of the **Old Vineyard** being guided to return, by the illegal tenants that wanted to keep the Vineyard for themselves, by killing the Heir.
They did.

Hence **Matt 23:38**, = **Dan 9:27** Right?

The Restoration is not tribal of flesh,

it's based on Truth at the appointed times of the workers on the parabolic time clock

6:00 AM, 9:00 AM, 12 and 3PM and 5:00 PM.

Each prophetic time, mentioned by Jesus was a <u>true</u> restoration, in the **New vineyard**.

Whereas, the Restoration of the X10 lost tribes is inherently linked with **3T** restoration.

The Restorations however of the **New Vineyard** 

culminates in the **Key of David** and **New Jerusalem**.

And the **Seal of two Fathers** = Rev 14:1.
