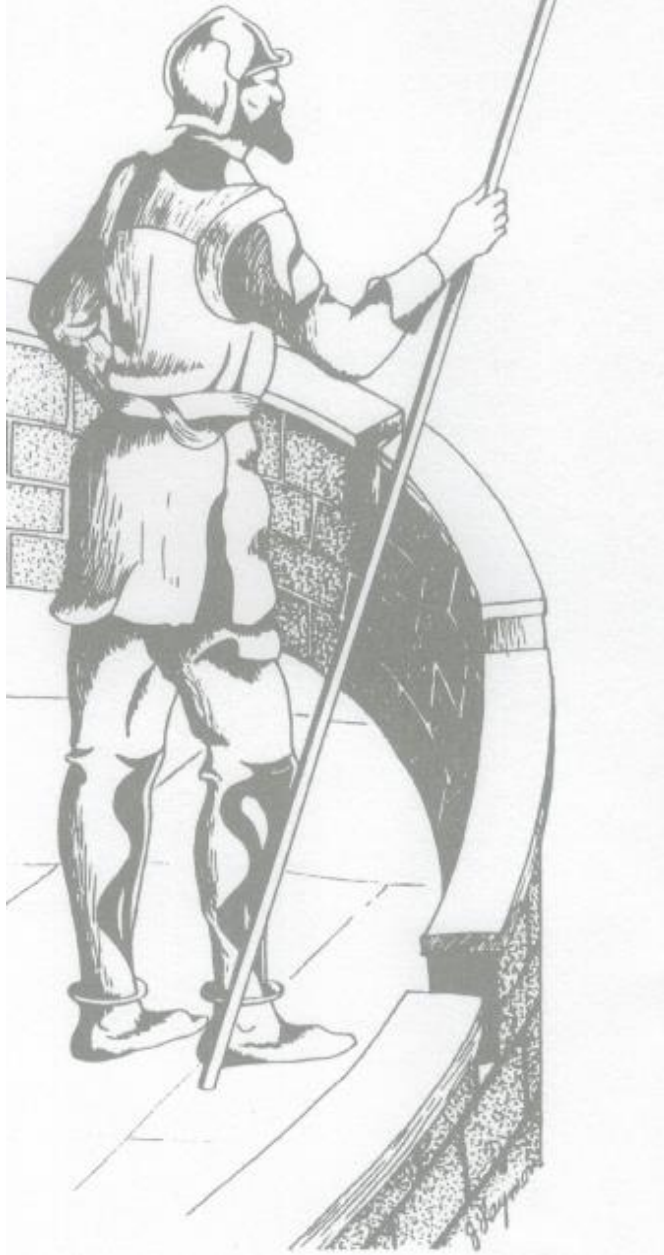

# LAW OF THREE

The last week, yes the last week of the 70 weeks of Daniel 9 is a big problem for Laodicea, Protestants in general, as well as the Messianic.

But, **ushering in Eternal Righteousness** must occur and thereupon exists the pinpoint of the L1 problem and insights with the **Law of Three.**

Why?

Why? Because the L1 doctrine existed long prior to Bethlehem and because Plato who devised the deviation courtesy of the mystery of iniquity developed the emanated logos by way of the energetics of the universe and that led to other similar dissipated L1 doctrines about Gd

Examples would be the mysteries of Jupiter Dolichenus (Gd of forces) see Daniel 11 and Mithraism practiced in the era of the terrible fourth beast of Daniel 7 developing into the TTD of the RCC at Nicaea etc

And therefore the **Divine Reality of the Law of Three**  
To commence at Bethlehem the L1 was interjected into the understandings of the GDHD.  
With the New Entrant of the GDHD at Bethlehem  
by way of HWM  
born into HUMANITY  
the Omega scenario of the A&O  
this confirmed the Divine Mandate from the Counsel of Peace the Third Entrant of the temporary Law of three (L3)  
was the monogenes theos (uniquely begotten)  
of John 1:14

And therefore we have the entire basis of why Christ said He was  
First and Last  
just as  
He then stated in the same Divine Epithet  
I AM A&O

And that detail is all about  
**the USHERING in of Eternal Righteousness**  
into HUMANITY and sustains the  
TWO Alpha's (AA) of **John 1:1**

And mind you were recently found in the  
Great Pyramid  
([here](#))

The Reality of the L2 prior to Bethlehem which exemplifies  
is ER it means ER had to be ushered into humanity

Yes the GDHD was temporarily altered and it was  
in respect to resolving the sin problem in sinful flesh.

**The L3** is not the Triune Trinity heresy = L1

And courtesy  
of the mystery of iniquity

**No, not at all.**

John said there were **TWO Divines** in beginning (Jn 1:1)

The Gospels reveal from Bethlehem and ushering ER

as in a temporary **Heavenly Trio**,  
and that detail cannot be a TTD as in FB #4 nor  
God Eternal Son heresy

Why?

Because John in the Apocalypse defines the

nuances of the transcendent transition in  
pictorial form with Revelation 4 and 5  
and this was discussed  
some yrs ago,  
here at 5A.

The transcendent transitional change with the Eternal Dynamics of ER of John  
1:1 must be altered

and ER parlance must enter by way of the doctrine of ERxF  
but had remained completely hidden  
since it was described by Daniel in chapter 9.

But it was always there!!

Few if any took notice of ushering of ER  
And that that detail brings in

The temporary GDHD  
as in the  
Law of THREE

Certainly it's impossible in the Trinity because the survival of the TTD is God  
the Eternal Son FB #4.

All those versions leave you fully cooked and unable to focus  
On why ER was to be ushered in.

For example ER ushered in means the Incarnation  
And that fact never existed prior to Bethlehem

And also the fact that detail destroys GTES

The L3 was the unto us a Child is born a son is given

And then that established ER

Into the human context and the entire sin problem

The L3 was by way of many important aspects and features and insights

That firmly remain an anchor to the soul

being HWM was to be the ONLY A&O

ever to exist and that was predicated

on ER being ushered in

from Bethlehem

and specifically John who described that child who is born

= Revelation 12:4 as the

monogenes Theos.

The uniquely begotten God

The Omega = Bethlehem.

Yet the Dragon even then

attempted to devour the resolution of sin problem

by the Incarnation of ER by virtue of Romans 1:3,4

Therefore the mystery of iniquity must construct a façade to

Eternalise the L1 to meet the exposure

to the Truth of the

1) Law of 2 (John 1:1) then

2) the Law of 3 (John 1:14) then resumption

3) Law of 2 in (Rev 22)

**The Ushering in of ER,  
gives us all insights of**

**L2, L3, L2**

This is first time 5A has mentioned to readers the

**Law of Three**

in any doctrinal context

and this is the right time to

Bring the attention of the importance of Dan 9:24

And ushering in of ER by way of the L3.

But also the Three Angels messages of Revelation 14.

Let that sink in!

As you can see

the L3 is predicated on John 1:14

and Dan 9 and the First angel

of Revelation 14

though a little unseen in the first instance.

L3 must confirm many things

And what it must disprove

and it does disprove many things about the assumptions of the TTD and this is featured in Isaiah 9:6-7

**A child is born a son is given  
That Child is also Everlasting Father  
and there you have ER  
Exemplified in Divine facts.**

**The L3 cannot and does not , and never will,  
confirm the horrendous  
Omega of DHs**

**= God the Eternal Son** FB #4

**Which is the putrid infested rootstock  
of the TTD = FB 2,4,**

**all courtesy of the conjuring and dissipation of the L2  
and consequently the misappropriation of the L3**

**by the mystery of iniquity which is to give life  
and perpetuate the L1.**

Those who cannot appreciate the  
**temporary nature of the L3**  
are not completing the facts of Scripture and  
remain babes on the milk but no one can dispute  
the L3 terminates and the L2 resumes at Rev 22.

The termination of the L3 is consequential  
to the Seal of Gd

Right?

The sequence from Scripture is

**L2, L3, L2**

There was no separation between  
**Ruach Hakodesh** and the **Angel of the Lord** in  
The Old Testament.

Why?

Because the **Law of 3** was **not present**  
**prior** to Incarnation.

So the **Law of 3** has as when as you will finally discover

has a VAST definition  
which is the revelation of the A&O  
the latter (Omega) being,

The Offspring of David for  
2 specific reasons .

1. The dispersion of ALLOS = inclusion of man AND
2. THE KINGSHIP OF THE A&O over planet earth.

L3 = John 1:14

Remains an excellent fact in explaining  
Why, the L1 is fake in every vestige  
it has emanated doctrinally  
into the Consciousness of humanity  
and theological culture  
especially in the closing scenes  
of earth's history.

One example is fact A&O represents  
its own Divine Subset of L2

= (HWM + Allos.)

This is very important.  
So slow down and pay attention because

In Deut 6:4 - HWM is L2  
(Echad with Allos == Holy Spirit Ruach)

L2 means HWM is **Not Yachid**  
with a separate Allos.

The TTD and L1 says  
Father is not the Son; the Son is not the HS.  
Yet that cannot be established by John 1:1 and L2 anyway

TTD is a misnomer  
Where the Yachid mismatch of Deut 6:4  
and deteriorates everything about ER and the L2  
and is the penultimate drama of the theological ages  
at the 1290 days of Matt 24:15 but also

at Har Moed. (Armageddon)

How?

Well everyone knows the Father, Son, Holy Spirit

Is inseparably conjoined to L1

With GTES

being the **L1 taproot**.

Which means you have the **Omega of DHs** tainting everything

and it's the main doctrine of Christianity

the Shema and the Shahada – only one gd

but also in 1982 in Lima Peru saw

the TTD is crucial unity of

the assembly and unity with the BEM

The BEM faith and order purpose

Is to express globally the convergences and differences in fundamental areas of the churches' faith and life. Serves as a basis for mutual recognition agreements among churches and emphasizes the importance of achieving greater Church unity

and the TTD with GTES doctrine is guess what?

Yeh, L1 front and central.

Again YACHID = literally one is adopted from Plato L1

But here is the Divine problem they all have to deal with

all of what they say

never touches the Divine Mandate

with L2, L3, L2.

The L3 establishes

A&O etched in stone.

## **LAW OF THREE**

### **Definition**

The L3 is a temporary status,  
between the Law of 2  
by way of the alteration of the GDHD,  
the Eternal Two of John 1:1  
in respect to the Everlasting Gospel.

L3 required the "Ushering in" of ER by the entrance of the Third Identity the  
- monogenes theos of John 1:14 the man-child and that He, Christ, by Divine  
Authority of ER that He is First and Last, the A&O to resolve the sin problem  
in humanity with the defeat of the mystery of Iniquity.

**L3** has to work from the vantage point of the  
Original holistic units of the Anthropomorphic  
Manifestations of the Angel of the Lord  
**And** Ruach Hakodesh.

This is where the TTD gets this all out of genuineness and JOHN correctly addressed this issue from The original blueprint of the Anthropomorphic and Ruach manifestations, Commencing with the L2 in John 1:1

whereas the **Triune Trinity god** = L1 is especially in relation to the "Father and Son" Is rooted in Philo and Neo Platonisms "universe" religion.

Its Arian over and over.

The Arian guys of today and they know who they are the Father / Son all say the Son was emanated in eternity so they have their problems with the L1.

Just as a one-time child that was born and son  
Given.

**The First and the LAST**

"Begotten not made" as versed in the Credo.

Next fact is the Law of **ONE-TIME**

L3 present what was BORN in reality in the Omega scenario of HWM as the uniquely begotten Gd?

Rev 4 / 5 as you saw in the pictorial illustration link above
